THE CANONS OF DORT

- ◆ The Remonstrants desired the Reformed church's doctrinal standards be revised and their view to be protected by the government.
- To avoid a civil war, the Netherlands voted to call a national Synod in 1617.

THE REJECTION OF ARMINIAN ERRORS

I. Who teach: That the will of God to save those who would believe and would persevere in faith and in the obedience of faith is the whole and entire decree of election unto salvation, and that nothing else concerning this decree has been revealed in God's Word.

Refutation: This error is deceptive and clearly contradicts Scripture, which declares not only that God will save those who believe but also that He has chosen specific persons from eternity. Within time He grants to these elect, above others, both faith in Christ and perseverance.

How can we be sure that belief is of God?

- John 17:5-8
- Acts 13:48
- Eph 1:4

II. Who teach: That there are various kinds of election: one general and indefinite, the other particular and definite, but the second can be incomplete and conditional or complete and absolute. There is also election to faith and another election to salvation.

Refutation: This is all an invention of the human mind without any Scriptural basis.
